The Order Prescribing the Import, Export Process Conducted by One ID One Shipment and One ED One Shipment System

1. The Ministry of Planning and Finance, the Customs Department, by exercising the authority provided under the Sea Customs Act Section 204, Sub-Section (b), and this order has been issued for the purpose of the facilitation of inspection for cargo vehicles, enforcement of customs control, and prevention of illegal imports and exports.

Submission of Import Declaration form

2. For the import of goods, One ID One Shipment system shall be practised in a suitable way among the under mentioned methods;

- (a) Where there are various kinds of goods on a cargo vehicle, grant the completion of customs clearance by only a filing of import declaration form.
- (b) Grant the filing of one or more import declaration form(s) which has been completed for the customs clearance, for the goods loaded on a cargo vehicle. (Loading by leaving balance of goods prescribed in the import declaration form shall not be absolutely granted.)
- (c) If only one kind of goods has been prescribed in an import declaration form, up to (five) number of vehicles will be granted and the inspection and paying duty and taxes shall be conducted within a day. (Loading by leaving balance of goods prescribed in such import declaration form shall not be absolutely granted.)

Submission of Export Declaration form

3. For the export of goods, One ED One Shipment system shall be practiced by the suitable way among under mentioned methods;

- (a) Where there are various kinds of goods on a cargo vehicle, grant the completion of customs clearance by only a filing of export declaration form.
- (b) Grant the filing of one or more export declaration form(s) which has been completed for the customs clearance, for the goods to export loaded on a cargo vehicle. (Exporting by leaving balance of goods prescribed in the export declaration form shall not be absolutely granted.)
- (c) If only one kind of goods has been prescribed in an export declaration form, up to (ten) number of vehicles will be granted and the inspection and paying duty and taxes shall be conducted within a day. (Exporting by leaving balance of goods prescribed in such export declaration form shall not be absolutely granted.)

4. This order has been issued, therefore, that the customs checkpoints in the border area shall exercise in accordance with the provisions of paragraphs (2) and (3) since 1-7-2023.
